The major research question is: Why have Turkey and Greece developed a “more conflict-less cooperation” oriented relationship, rather than a “more cooperation-less conflict” oriented one, despite their institutional relationships within NATO and on the margins of the European Union? The dissertation explores the role of NATO and the EU in the (re) construction of self-help based security relationship between Greece and Turkey.
